#### **1. ARE PROPONENTS REQUIRED TO SUBMIT A TENDER SECURITY BOND WITH THEIR PROPOSALS?**

A Tender Security Bond valued at Twenty Thousand Dollars (TTD \$20,000.00), is required for this RFP. No cheques will be accepted. Failure to submit the required original bond along with the proposal will result in disqualification.
